Study of moist	ture influence on semi-wool worsted fabrics shrinkage60
	The article results the study how finishing processes and variously temperatured moisture influence on the shrinkage of semi-wool worsted fabrics and threads that they are obtained from. A comparative analysis of the obtained shrinkage values was carried out when the threads and fabrics were moistened with 20, 50 and 90 °C water and when the samples had the treatment corresponding to the washing and welding stages of finishing. It has been revealed that water temperature influences on shrinking half-woolen worsted threads and fabrics as well as their properties: composition, weaving (structure), surface density for fabrics; composition, linear density and twist for threads. Key words: shrinkage; worsted fabrics; threads; wet-heat processing.
